- The Stock Units ("Units") convert to Common Stock on a one-for-one basis.
- Reflects Units received upon deferral of a portion of the reporting person's annual incentive plan into the Company's stock fund and the premium contributed by the Company on such Units. The Company premium, or 9.922 of the acquired Units, are subject to vesting based on employment through December 31, 2020.
- The Units are payable in Common Stock upon earlier of termination of employment or January 1 following retirement.
